Incidents

On May 1st, 2024, Officer Gennaro took a report for a scam over social media regarding a set of concert tickets. Money was exchanged, and the tickets were not received. The incident was documented.

On May 6th, 2024, Officer Houle responded to several Main Street businesses reporting that an individual entered the business and requested that billing information be verified on the Amazon account. The individual left the area, which was searched with no results.

On May 7th, 2024, Officer Muraguri responded to Dunkin Donuts for a report of a stolen bicycle. The area was searched with negative results. Officer Muraguri will gather video footage of the surrounding area.
