# Incidents

On June 2<sup>nd</sup>, a resident reported a possible phishing scam where someone requested that she verify her social security number for an Amazon.com purchase. The resident was advised to notify her banking institutions, and a report was filed.

On June 5<sup>th</sup>, a resident reported their vehicle stolen from a Main Street address. The vehicle was entered as stolen into NCIC. It was later determined the vehicle had been repossessed.

On June 13<sup>th</sup>, Officers were dispatched to the Beijing Royal School for a report of vandalism and significant damage to the building. On arrival Officers were met by school employees that showed them broken windows, graffiti, spilled liquids and paint, and general destruction of property. Evidence was gathered, and the matter was forwarded to Detectives.

On June 20<sup>th</sup>, Officers were again dispatched to the Beijing Royal School for a report of three individuals seen inside of the building on camera. Mutual aid was requested from the Acton Police Department, and K9's requested. Officers and K9's cleared the building, and it appears the subjects had already left the area prior to arrival. The footage and incident was forwarded to Detectives.
