On Thursday September 2<sup>nd</sup>, 2021, the Maynard Police and Fire Department responded to Park Street for a fatal two-alarm fire. Public Safety Communications received a report of an odor of natural gas, and of an explosion were received subsequently.

A motor vehicle accident caused significant damage to a fire hydrant on Sarah Lane. The accident resulted in low water pressure and discolored water in some areas.
