Incidents

On October 1st, an employee of Market Basket reported that her bicycle was stolen from behind 4 Digital Way. The bicycle was reported as a black trek.

On October 6th, Ofc. Wellborn took a report of a mailbox that appeared to have been struck by a vehicle on Parker Street. The incident was documented.

On October 11th, Ofc. Blackington took a report from a resident who stated that she received an email from Walmart confirming a purchase that she did not make. When the resident reviewed her account there were two additional suspicious purchases. Walmart was alerted to the fraudulent activity and the accounts were secured by the reporting party.

On October 13th, Ofc. Gennaro took a report of a resident that was attempting to sell a painting online and who had been issued a fraudulent check. The incident was documented and no funds were taken.

The Maynard Police Department is seeking out the operator of what was described as a Silver Toyota Venza that was involved in an motor vehicle accident at the intersection of Thompson Street @ Great Road on October 14th. The incident was documented and the trailer was secured.

On October 19th, Ofc. Moore and Ofc. McCann responded to 15 Digital Way for a report of juveniles attempting to knock over port-o-potty's. The juveniles left on foot, and Officers were not able to locate. No damage was recorded.

On October 23rd, Dispatch received numerous reports of loud explosions. The source was determined to be Fort Devens performing demolitions.
