On February 1<sup>st</sup>, Ofc. McCann took a report of three fraudulent checks that were written from a Maynard business totally over \$9,000. Ofc. McCann is working closely with the business and their bank for further information. The matter is under investigation.

On February 7<sup>th</sup>, Mill and Main Place Security reported there was new graffiti in the parking garage and stairwell. The graffiti was documented.

On February 9<sup>th</sup>, Officers responded to a residence for a report of a dog bite that occurred earlier in the day. The individual reported that while walking by a residence there were two unleashed dogs outside. One of the dogs ran toward the individual walking by, and bit her below the knee. Officers attempted to contact the owner without success. The incident was forwarded to Animal Control and will be investigated.

The damage was caused by a plow operator, who acknowledged the incident and stated that the company would take care of damages. Ofc. Wellborn contacted the company to follow up.
