# Incidents

On March 2<sup>nd</sup>, Officer McCann took a report from an individual that allowed a company called “Awery Remote” to gain remote access to her computer. The individual gaining access was able to transfer funds from her savings to checking account before she shut the computer down. The individual contacted the bank and was able to stop further activity.

On March 4<sup>th</sup>, an Enterprise employee reported a vehicle had been returned with what appeared to be drugs inside of the vehicle while cleaning. An Officer responded and took possession of the baggy. Officers attempted to contact the previous renters without success. The incident has been documented, and baggy placed into evidence.

On March 5<sup>th</sup>, Officers responded to Dunkin Donuts on Digital Way for a report of a group of juveniles harassing an employee and attempting to enter the locked establishment at closing. Officers searched the area with negative results and waited with the employee until closing. The incident was documented.

On March 7<sup>th</sup>, Officers responded to Jiffy Lube for a report of an employee that was struck by a vehicle being serviced. Those on scene were interviewed, the employee was treated and transported by the Maynard Fire Department , and an accident report was filed.

On March 10<sup>th</sup>, a resident reported that a catalytic converter had been cut off a truck and two backpack blowers were stolen from the vehicle. The incident is under investigation by Detectives.

On March 19<sup>th</sup>, Ofc. O’Neill observed a damaged parking meter located in the municipal parking lot near El Huipil. The damage was documented.

On March 23<sup>rd</sup>, Ofc. Blackington responded to Excelsior Games and Comics for a report of shoplifting. The shop owner presented surveillance footage that captured the incident. The individual concealed merchandise valued at approximately \$20.00. Officers later identified the individual and the incident remains open.

On March 26<sup>th</sup>, the Maynard Business Alliance reported that lights that had been on the fence, trees and lights had been taken off and the lights had been destroyed. The lights had not been removed by any Town agency. The lights are valued at approximately \$200.00-\$300.00. The damage and incident were documented.

### Common Money Scams:

**Bail/Accident** - Someone will call and say that a family member was arrested or was in an accident and demand money.

**Contest Winner** - Someone will call and say that you won a contest or the lottery and demand that you send money in order to get the winnings.

**Computer Support** - Someone pretending to be tech support will call and state that your computer has a virus/has been hacked and will demand money to have it repaired.

**Internet Sales** - You sold an item and received a check for too much money and were instructed to deposit the check and wire the overpayment amount back.

**IRS** - Someone pretending to be from the IRS calls and demands immediate pay for taxes.
