On June 6th, Officers spoke with an individual that reported that she had been receiving debit and credit cards in the mail that she had never applied for. Additionally, someone had opened an SSI in her name in Ohio. Officers advised her on what steps to take to secure her information and cancel these accounts. The incident was documented.

On June 7th, Officers responded to a residence on Summer Street where a detached garage was reportedly on fire. Officers confirmed that no one was inside of the structure and aided the Fire Department until the fire was knocked down.

On June 8th, a resident reported that over \$8,000 had been taken from his checking account and it appeared as though someone had stolen a check from his checkbook. The bank had already refunded the amount, and his account was secured. The incident was documented and under investigation.

On June 16th, Officers responded to a local business where the owner stated that her gas line had been cut to one vehicle, and gas had been stolen out of other vehicles. While on scene the Officer noticed the gas caps had been removed from other vehicles, and it appeared as though gas had been siphoned from them as well. The Detective unit is reviewing camera footage, the matter is under investigation.

On June 16th while on routine patrol, Officers noticed new vandalism inside of the electric charging station stairwell. The incident was photographed, and patrols will continue to check the area.

On June 22nd, Maynard DPW staff reported that three weed whackers and the gas line of a vehicle was cut. The incident was photographed and documented. The area will be added for extra checks.
