During the first week of September Officers responded to numerous reports of catalytic convertor thefts in Maynard. The incidents are under investigation, and a notification was made to the community.

A resident reported that they had been contacted by a "scammer" claiming to be with the Publishers Clearing House with a prize for this individual. The individual was directed to purchase a gift card and provide personal information. A report was filed, and the resident was advised to monitor bank accounts, their credit, and file a complaint with the Attorney General's Office.

On September 16th, Officer Davoll responded to the Rockland Avenue Soccer Fields. A coach reported that a vehicle had driven onto the fields causing damage to the grass. The incident was photographed and documented.
