# Incidents

On Sunday November 6<sup>th</sup>, 2022 a resident reported that their vehicle had been struck on Digital Way while they were inside of a business. A witness provided a description for the striking vehicle, and Officers are investigating the matter.

On Monday November 7<sup>th</sup>, 2022 an individual reported that they had purchased approximately \$2,000 in gift cards after receiving an email from someone posing as his employer. The individual was advised to contact his employers and his bank of the scam. The matter is under investigation.

On November 10<sup>th</sup>, 2022 a resident reported that a tool chest weighing approximately 80lbs, and the tools inside were stolen from the bed of his truck. The value of the tools was approximately \$3,000. Officers canvased the area for video footage, and the matter is under investigation.

On Monday November 14<sup>th</sup>, 2022 Officers were dispatched to a pump station for a report of equipment that had been vandalized. The calling party reported seeing three individuals dressed in bright orange near the excavator. The excavator door had been opened, and a large amount of brush had been put inside. The owner of the excavator was notified and the incident documented.

On Friday November 18<sup>th</sup>, 2022 a resident on Powder Mill Road reported that two fishing poles and a metal detector had been stolen at some point from his vehicle. The individual was advised to lock the doors to their vehicle going forward, the area was canvased for camera footage and the incident was documented.
