Maynard Police and Fire Departments Receive Life Saving Awards

Police Chief Michael Noble and Fire Chief Angela Lawless are pleased to share that three Maynard Police Officers and five Maynard firefighters were recently presented awards for their combined efforts to save a life in April.

The awards ceremony was held Tuesday, June 6, during a Select Board meeting at Town Hall. Recipients included Police Sgt. Trista Manchuso, Officers Eric Davoll and Kristin Gates, Fire Capt. John King, and Firefighters James McGowan, Ryan Johanson, Mark Latta, and Jack Primiano. Awards were presented by William Doyle, whose life they saved.

On April 8, Maynard Police and Fire were dispatched to a home where a man had become unresponsive.

Upon arrival, Maynard Police located Doyle and began to perform CPR compressions. Maynard Fire arrived moments later, taking over compressions and using an Automatic External Defibrillator (AED). Doyle was transported to an area hospital by Maynard Fire, while Doyle's family was driven to the hospital by Maynard Police. Due to the quick actions of Maynard's first responders, Doyle was alert and talking when he arrived at the emergency room. The next day, Maynard Police and Fire contacted Doyle's family to check on his recovery. It was determined Doyle suffered a massive heart attack.





Incidents

On June 2nd, Ofc. Davoll took a report of a female that struck at a low speed by a motor vehicle, causing her foot to be run over the previous day. Ofc. Davoll was able to get into contact with the operator of the vehicle, a citation was issued and a report was filed.

On June 6th, Ofc. Houle took a report of laundry that was stolen from a dryer at the laundromat, valued at around \$700.00. Two males were seen on the video taking the laundry and leaving in a small grey hatchback vehicle. The incident is under investigation.

On June 10th, Ofc. Gates spoke with an individual whose vehicle was struck while at the Boston Bean House. The individual who struck the vehicle left the scene. There did not appear to be any damage to the vehicle. The incident was documented.

On June 18th, Ofc. Davoll took a report from a Walgreens manager in Manchester New Hampshire. The manager believed a false Western Union account had been opened in a Maynard resident's name and money had been sent to Mexico using the account. Ofc. Davoll followed up with the resident, and advised them of actions to take to protect their identity and information.

On June 23rd, Officers responded to a report of a stranger that entered a residence, and was seen by the homeowner. The individual left on foot and was located by Sgt. Bodwell. The individual stated that he worked for a pest control company and entered the wrong residence. The family was informed of the misunderstanding.



Community Outreach

On June 1st, Officers responded to free a fawn that had been trapped in a fence at the local power sub station. The animal was uninjured and released.

On June 6th, Pebbles from Hot 96.9 Boston highlighted the value of comfort dogs in Public Safety, and our very own Otis the Comfort Dog (AKA Otis the Good Boy) was featured. Otis's handler SRO McCann was interviewed and quoted saying "When a child is having a bad day, you would be amazed at how fast he turns it around for them-tears stop flowing in seconds (no exaggeration)!" The addition of Otis has been wonderful, we are lucky to see the immediate positive impact that he has in our community, not to mention the positivity he brings to our workplace each day. We thank the community for supporting the Maynard Police Department, and Otis!.

On June 9th, SRO McCann and Otis were there to celebrate our Maynard High School Class of 2023!
