# Incidents

On October 10<sup>th</sup>, 2023, Ofc. Gennaro responded to a residence to take a report of damage to a vehicle the occurred at Market Basket earlier in the evening. The individual stated there was damage to her bumper when she finished shopping. Ofc. Gennaro documented the incident and requested footage from Market Basket.

On October 14<sup>th</sup>, 2023, Ofc. Gates took a report of a suspicious package that was delivered to the residence and was not addressed to the occupant. The package contained pills that were placed into evidence.

On October 17<sup>th</sup>, 2023, Ofc. Houle responded to the area of McKinley Street for a report of solicitors with out the proper permits. This was the second report of these individuals. Ofc. Houle advised them on the proper process, and they left the area.

On October 18<sup>th</sup>, 2023, Ofc. Houle responded to Nason Street Cleaners for a report of stolen laundry. The individuals were identified, and it turned out to be an error, as the individual was picking up laundry on behalf of a family member. All items were returned.

On October 25<sup>th</sup>, 2023, Ofc. Oliveira took a report of property damage to a lawn and walkway. A tree company had been at a neighbors and may have caused the damage. The neighbors were put into contact, and arrangements to fix the damage were made.

On October 27<sup>th</sup>, 2023, Ofc. Banatoski took a report of a hit and run motor vehicle accident. Officers were able to locate the striking vehicle, the damage was documented, the operator was issued a citation and information was exchanged for insurance purposes.
