Incidents

The vehicle was eventually returned, and the vehicle was removed as stolen from NCIC.

On November 6th, 2023, Ofc. Riviere responded to Market Basket for a report of a hit-and-run motor vehicle accident. The incident was documented, photographed, and is under investigation.

On November 8th, 2023, Ofc. Davoll responded to Silver Hill Road for a report of multiple trash bags filled with leaves that were discarded into the woods. The area was searched for camera footage, and DPW was notified to arrange for cleanup.

On November 9th, 2023, Officers responded to the area of Marlboro Street for a report of a motorcycle engine being revved. The individual was advised.

On November 12th, 2023, Ofc. Seeley spoke with a resident who had been locked out of her META account, and two charges had been made to a Bank of America account. Both charges were denied, and she was advised to contact her bank to report the activity. The matter is being investigated.

On November 15th, 2023, Ofc. Riviere responded to a Mill and Main Place business for a report of a stolen check of approximately \$14,000 that had been sent to Florida. The incident was documented, and they were provided the information for their banking institution.

On November 18th, 2023, Sgt. Sutherland located graffiti on the walls of the Mill and Main Place Parking Garage during an area check. The graffiti was documented, and the property owner was notified.

On November 20th, 2023, Sgt. Bodwell responded to a residence on Garfield Street for a report of a damaged motor vehicle. The mirror had been damaged at some point during the evening while parked on the street. The incident was documented.


