# Incidents

On December 7<sup>th</sup>, 2023, Officer Avril responded to the Verizon store on Digital Way for a report of an unknown individual who had been inside the store and had already scammed another location out of \$4,000. The individual had since left. Ofc. Avril documented the incident and was in contact with the District Manager.

On December 10<sup>th</sup>, 2023, Ofc. Gennaro and Ofc. Banatoski responded to 7-Eleven for a report of an individual loitering and causing a disturbance. The individual left the store before arrival, however, was identified and a no-trespass order was issued.

On December 14<sup>th</sup>, 2023, Ofc. Riviere responded to a Main Street business for a report of a past larceny of office equipment. The business was photographed, and the incident is under investigation.

On December 15<sup>th</sup>, 2023, Ofc. Riviere responded to Market Basket for a report of damage to a vehicle. A vehicle had sustained damage while the owner was inside the store. The vehicle was photographed, and the incident was documented. There were no cameras in that area of the building.

On December 18<sup>th</sup>, 2023, we faced some serious winds and rainfall in Maynard. Our Communications Center received numerous reports of downed trees, wires, and power outages. The calls were processed and handled by Police, Fire, and DPW.

On December 21<sup>st</sup>, 2023, Officer Davoll and Officer Houle responded to Market Basket for a report of shoplifting. A male party left the store without paying for groceries. Employees directed Officers to the male party, who was stopped. The groceries were returned, a no-trespass order was issued, and he was issued a summons to appear in court.

On December 27<sup>th</sup>, 2023, Officer Seeley spoke with a resident who received a phone call from a "lawyer" stating that a friend was in jail and in need of \$23,000 to be bailed out of jail. The individual was able to ask questions and ascertain it was a scam phone call. The incident was documented.
