# Welcome to Maynard

Officer Daniel George graduated from the Lynnfield Police Academy 4th and was sworn in as a full-time Police Officer.



#### **Incidents**

On January 3<sup>rd</sup>, 2024, Maynard Police and Fire responded to a vehicle that crashed into the building at Christmas Motors.

On January 3<sup>rd</sup>, 2024, Officer Houle responded to Cumberland Farms for a report of damage to a vehicle that occurred several days earlier while parked in the lot. There is a report on file documenting the damage.

On January 5<sup>th</sup>, 2024, while on routine patrol Sergeant Bodwell was flagged down by a resident on Main Street that had located an 8-inch kitchen knife stuck in a fence. The knife was removed and taken for safekeeping.

On January 9<sup>th</sup>, 2024, Officers Gennaro, Muraguri and George responded to Market Basket for a report of shoplifting in progress. Two females left the store without paying for a large amount of hair products. A Market Basket employee confronted the individuals who then abandoned the items in the parking lot and left the area. The matter is under investigation.

On January 14<sup>th</sup>, 2024, Officers Houle and Davoll responded to Wendy's for a report of a disturbance. A customer had been upset that a mobile order was not complete, and the customer was irate and exited their vehicle yelling at employees through the closed drivethru window and punched the window. The incident was captured on video and it under investigation.

On January 15<sup>th</sup>, 2024, Officer Banatoski responded to Ice House Landing for a report of vandalism to the monument. The monument had been sprayed with white spray paint. Officer Banatoski canvased the area for cameras, and the incident was documented.

On January 15<sup>th</sup>, 2024, Officer Gennaro and Officer Seeley responded to Elm Court for a report of eggs that were thrown at multiple vehicles. The incident was documented.

On January 22<sup>nd</sup>, 2024, Sergeant Sutherland took a report from a local business that reported an employee had stolen material worth upwards of \$8,000.00 and taken it for personal use. The employee had been terminated, the incident was documented, and charges were filed.
